

2-1-1 Nevada County provides consumers with CalFresh information and assistance. In September, CalFresh outreach and education was completed with  $\bf 27$  of callers, up  $\bf 4$  points from last month. CalFresh was discussed with  $\bf 49$  other callers who were calling for other reasons.


# Who We Are Helping


